PRODUCT DESCRIPTION

DECONTAMAN PRE WIPES are ready-to-use wipes for antimicrobial cleaning of the skin. The large washing wipes are made of robust, pleasantly soft non-woven fabric and are impregnated with a mild disinfectant solution containing 2% chlorhexidine. It is not necessary to rinse the skin after cleaning with **DECONTAMAN PRE WIPES**. Thanks to the film of active ingredient that remains on the skin as a result, 24-hour residual action against bacteria is achieved.

APPLICATIONS AND NOTES

Range of application According to the Biocidal Products Regulation (BPR)

Professional, antimicrobial skin cleansing, particularly in case of colonization with multidrug-resistant bacteria and before hospitalization or outpatient visit (presurgical).

Application

Take the wipes from the package, wipe the selected skin area and leave to work for at least 5 minutes. For each skin area use a new wipe according to the scheme for whole body washing. Please avoid areas around the mouth and eyes as well as the mucous membranes of the intimate and buttock regions.

Application notes

Do not use in infants or in cases of known intolerance to chlorhexidine. Strictly avoid contact with eyes, ears and injured skin. Not suitable for skin disinfection before invasive procedures/surgical skin disinfection.



Heat in the microwave (600 W - 20 seconds).

Heating times may vary depending on the microwave. Before using the wipes ensure that they are not too hot. Do not reheat already opened packages. The wipes are intended for single use only. **DECONTAMAN PRE WIPES** are therefore highly suitable for time-saving yet thorough cleaning of skin colonised with MRE and can also be used as part of pre-operative patient preparation.

Composition

100 g solution contain: 2 g chlorhexidine digluconate. Contains perfumes.

Sequence for body bath





Face 1

The person should keep their eyes closed while you wash their face. Make sure that no cleaning solution gets into the eyes or ears.

Chest/Stomach 2

Wash the chest, stomach and belly button from the neck down. While washing, make sure that the lower body is kept warm.

Arms 3(4)

Starting with the finger tips, wash the hands and arms up to the shoulders. Pay special attention to the armpits.

Back 5

Sit the person up, or turn them to the side, and wash their neck and back from the sides towards the middle. Dress upper body and position the person on their back.

Legs 67

Then wash the legs from the hips down.

Feet 8

First clean the toes and between the toes, then the remaining parts of the feet.



Intimate area

Cleaning the external genital area.

Genital area 10

Clean the outer genitals.

Important (!)

While washing, towels should be positioned so that the fresh bed linen does not come into contact with the unwashed side of the body. Avoid contact with the mucosa!
